Personal data

Personal data means any information relating to an identified or identifiable natural person.

The personal data processed by GTA Law Firm are those necessary to carry out the assignment: name and surname, but also particular data related to health and judicial data.

Data Controller

Data controller means the natural or legal person that determines the purposes and means of the processing of personal data.

The Controller is GTA Law Firm Studio Legale GTA STA S.r.l.

Data Subject

He is the natural person whose personal data is processed.

Data Subject is the legal representative of Company.



Data Processing

Any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure.

Required

The conferment of data is necessary for the execution of the assignment. The eventual refusal prevents the execution of the service.

Transfer data abroad

It is not intention of the GTA Law Firm to transfer data to a third country unless it is necessary to perform the assignment.

Recipient

Is a natural or legal person to which the personal data are disclosed.

Personal data may be known by: GTA Law Firm, professionals, employees, practitioners, domiciliaries in case of litigation, appointees. They can be communicated to all public and private subjects whose communication is necessary for the fulfilment of the assignment.

Purpose and legal applies

Purpose is the reason for which personal data is processed. Legal apply is the condition of lawfulness of the processing of personal data.

GTA Law Firm processes personal data for the correct and complete execution of the assignment, for the fulfilment of obligations of a fiscal nature, for anti-money laundering regulations, for the exercise of the rights.



Period of storage

Personal data processed by Law Firm will be retained for the duration of the assignment and for ten years following the end of the relationship.

Rights of Data Subject

Data Subject has the right to obtain from Data Controller the confirmation that a data processing is or is not in progress; the access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability. He has the right to lodge a complaint with the Control Authority.

A longer period may depend on requests from the P.A. or other judicial body or on Law Firm's participation in litigation.
